**RECOMMENDATION:**

Be it resolved that the Municipal Services Committee (MSC) recommends to Council that Councillor \_\_\_\_\_ be appointed to sit on the Delta Athletic and Recreation Society (DARS) Committee.

And further, that By-Law 2018-18 (Compensation and Remuneration for Members of Council) be amended to include the Delta Athletic and Recreation Society (DARS) with an annual stipend of \$400, as presented in MSC Report ADM-2024-05.

**BACKGROUND:**

The Delta Athletic and Recreation Society (DARS) passed Resolution #4-16-2024-14 at their meeting held April 16, 2024 requesting council to officially appoint a council member to their committee.

Council, at their meeting held May 6, 2024, requested a staff report be brought to a future MSC meeting outlining stipend costs related to appointing a member to DARS.

**DISCUSSION:**

Staff have reviewed the current stipend listing (attached) which lists all current Committees and Boards that Council members are appointed to and the relative stipend.

Staff have also compared the number of meetings held per year with DARS and other Committees/Boards and recommend that if it is the desire of Council to have a member on the Delta Athletic and Recreation Society, that the annual stipend be \$400.
