BY-LAW 2024-94

THE CORPORATION OF THE TOWNSHIP OF RIDEAU LAKES

BEING a By-Law to stop up and close those parts of the original allowance for road, known as St. Mary's Street, Registered Plan 27, Village of Portland, Township of Rideau Lakes in the County of Leeds and Grenville;

WHEREAS pursuant to Sections 8, 11 and 34 of the *Municipal Act 2001, c.25*, a Municipality may close a highway under its jurisdiction;

AND WHEREAS Part 3 of Plan 28R4230, being part of the street allowance between the Kings Highway 15 and Colborne St. in the Village of Portland, was deemed surplus to the needs of the Municipality on July 2, 2024;






