NEW BUSINESS

Location of Municipal Offices (For Discussion)

Members of the committee recognized that there has been much discussion and debate on this issue in the community, and recently a flyer was circulated by the Rideau Lakes Grassroots Group. A Special Meeting will be held on August 6 at 5:00 p.m. followed by the Council meeting at 6:00 p.m.

Several members shared that multiple options should be reviewed, and that cost be a consideration as well as location. Further that the economic benefit of locating the offices in a village, and the service benefit to residents be considered.

In terms of location, the municipally owned property on Harry Seeley Drive in Elgin would offer several advantages; it is in the village core (rather than on Hwy 15), the parking would be sufficient, the land is relatively flat, the type of soil would be appropriate for the septic system, the wetlands have been identified, and the property is

already owned by the municipality. Other members added that there is a school and seniors housing near to the municipal property.

It was a consensus that from an Economic Development perspective, locating the municipal offices in a village would be beneficial, that it would better represent Rideau Lakes to those entering the community, and that the added business activity would support the local economy of that village.

Committee Roundtable

Mayor Hoogenboom:

The importance of tourism was the subject of the Mayor's Video in July. In August, the subject will be campgrounds with a focus on Lower Beverley Lake Park in Delta. Met with business owner Fiona McKeen of The Opinicon, attended both the Delta Fair and the Lombardy Fair that draw a lot of people to the area. At the AMO conference from the 14th to the 21st, a delegation has been scheduled regarding abandoned cemeteries. In anticipation of the upcoming closure of the Lasalle Causeway, meetings with Westport, Merrickville and Smiths Falls have taken place to discuss temporary travel concerns as larger boats (taller than 14 feet) will not be able to pass. For example, cruise ships may choose to travel the St. Lawrence rather than the Rideau Canal Waterway. Municipal partners plan to make a joint presentation to Parks Canada and meet with MP Michael Barrett. A notice of motion is on the Council Agenda for August 6, and a formal resolution is expected at the September meeting, to lobby for an alternate solution. During the construction on Hwy 42, deep culverts to be replaced, paved shoulders and resurfacing impose a 2-week closure from Aug 12 to 26 whereby traffic will detour down McCann Road.

The Leeds County Plowing Match is taking place in Forfar this year.

Public Representative Ken Davies:

There will be construction on the bridge at Burnt Hills Road affecting traffic from Kingston for 2 years. It is suggested that this be an agenda item for the meeting with Parks Canada. Event at No. 9 Gardens. Delta Fair is a major tourist attraction.
